

# GENERAL CONTEST RULES

These rules govern all contests conducted by Woof Boom Radio Muncie LLC (WBR) or aired by any of the WBR's stations held by Woof Boom Radio Muncie Licensee LLC, including WLQQ-FM, WLBC-FM, WERK-FM, WMXQ-FM, WMUN-AM, WBKQ-FM, and WHBU-AM (individually or collectively referred to as the STATION(S) and any on the corresponding websites.

1. No purchase is necessary to enter any WBR contest.
2. Contestants must be at least 18 years old to win unless otherwise specified. Contests are open to legal residents who live in the following Indiana counties: Tippecanoe, Delaware, Grant, Blackford, Henry, and Madison.
3. Some WBR contests will have specific rules. These rules will be aired and published on individual station websites during said contests.
4. Only one winner per household per 30 days is eligible for a contest. Any prize awarded to an ineligible listener will be deemed null and void, and an alternate eligible winner may be named.
5. Employees of WBR, agents, successors, and assignees of any other radio station or television station, its advertising agencies, and promotional companies, as well as family and household members of same, shall be ineligible to participate in the promotion. They shall be ineligible for any prize covered herein.
6. WBR reserves the right to disqualify any winner if any contest rules are violated in any way.
7. The Contest and all the related pages and contents are copyright WBR. Copying or unauthorized use of any copyrighted materials, trademarks, or any other intellectual property without the express written consent of its owner is strictly prohibited.
8. Anytime an entrant calls the Station to participate in a contest, you permit the Station to broadcast or record your call for a later rebroadcast. As a winner of a WBR contest, your voice, name, and picture may be used for promotional, broadcast, or Internet purposes. Entrants further grant WBR the right to use and publish their proper name online and in print or any other media connected with the Contest.
9. A merchandise prize is not redeemable in cash. No prize is transferable. Prizes will not be substituted or transferred at the winner's request. WBR reserves the right to substitute a prize of similar value.
10. Prizes are offered as is with no written or express warranty. WBR is not responsible for replacing tickets due to show cancellation, weather conditions, promoter, performer, travel arrangements, or events beyond the Station's control.
11. All winners of all contests are responsible for all taxes on the prize awarded. Any winner receiving a prize or multiple prizes valued over \$600 must complete the appropriate tax forms at the WBR studios before receiving the prize. All winners will be sent a 1099 MISC federal tax form if, in one calendar year, the prize value of all prizes won exceeds \$600.
12. In the event the winner is subject to, or the subject of any order or legal proceeding by any governmental agency having jurisdiction over the affairs of the winner (i.e., garnishment, child support order, judgment, lien, and the like), WBR may deliver the prize to the official representative of the governmental entity claiming a right to the prize shall be thus deemed as

WBR awarding the prize to the winner. WBR shall be entitled to rely, in good faith, upon any documents presented by the representative seeking to collect the award instead of the winner. WBR shall not be liable for any claim by any winner for damages incidental to it.

13. Prize winners must possess a valid form of identification bearing the picture of the contestant acceptable to WBR that will be presented to WBR and accepted before the prize is awarded.
14. Winners will be expected to claim the prize at the WBR studios (unless otherwise noted), 800 East 29th Street Muncie, IN, between 8:30 am – 5 pm, Monday through Friday (excluding holidays) within two weeks of being notified that they are winners, unless there is an expiration date on prize which will be expressly stated.
15. All Federal, State of Indiana, and local laws and regulations apply. The contest is void where prohibited.
16. WBR, their advertising agencies, affiliates, contest sponsors, employees, and immediate families shall be held harmless from any action or liability arising from any contest or prize awarded in any contest.
17. Winners may be required to sign a release form agreeing to release and hold harmless the Station or WBR, its officers, directors, employees, sponsors, partners, agents, assigns, and affiliated companies.
18. As an FCC licensee and a trustee of the public airwaves, WBR reserves the sole right to interrupt or discontinue any contest or promotion (and not award the offered prize) at the discretion of WBR management if world events, the national mood, or public safety so warrant.
19. WBR reserves the right to amend the rules to any contest at any time. The judge's decision is final.
20. For Contests that use phones for entry.
  - a. The person operating the telephone at WBR has full authority to decide on the winning caller.
  - b. Contest phone lines are WLBC-FM (765)289-9522, WERK-FM (765) 378-2096, WMXQ-FM (765) 378-2094, WMUN-AM/FM (765) 287-1340.
  - c. These phone numbers or lines may be changed without written notice due to technical or unforeseen difficulties. WBR shall have no responsibility for failure to win or claim any prize based on difficulties with telephone, facsimile, email, internet difficulties, or any circumstances in any contest.
21. Contests using online or written entry forms:
  - a. All appropriate information in the required fields must be filled out, or you will be disqualified.
  - b. To win a prize, you must reside within the listening area of WBR, as defined at the exclusive discretion of WBR management.
  - c. Any problems with the Internet or email are not WBR's responsibility.

23. WBR may add additional rules that may differ from the General Contest Rules for a specific Contest or Promotion.
24. WBR may change these General Contest Rules at any time without notice.
